Subject: Re-determination of vacancies for appointment by promotion of Assam Police Officers to IPS of the Assam segment of the Joint Assam-Meghalaya Cadre for the Select List 2024.

Sir,

I am directed to refer to the Government of Assam's letter No. HAM.01/2025/589 dated 29.07.2026 on the subject cited above and also to this Ministry's letter of even number dated 04.04.2025 on the subject, whereby 10 vacancies (06 carry-forward + 04 superannuation) were determined for the Select List of 2024.

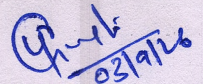
2. The authorized promotion quota of the Assam segment of the Joint Assam- Meghalaya Cadre of the Indian Police Service, as on 01.01.2025, was 42, against which 15 officers were in position on the due date, resulting in 27 vacancies. Out of these 27 vacancies, 17 vacancies were filled for the Select Lists of 2019, 2020, 2021, 2022 and 2023 vide Notification dated 17.01.2025. Further, 01 vacancy was filled by promotion of Shri Sanjib Sekhar Roy against the Select List of 2022 vide Notification dated 03.09.2026. In addition, 04 vacancies arose on account of the retirement of 04 promotee IPS officers during the year 2024, while 05 vacancies pertaining to the Select Lists of 2019, 2020, 2021 and 2022 to 2023 remained unfilled due to non-appointment of the concerned officers to the IPS and are required to be carried forward to the year 2024.

3. Accordingly, in terms of Rule 4(2) of the IPS (Recruitment) Rules, 1954, read with Regulation 5(1) of the IPS (Appointment by Promotion) Regulations, 1955, **09** (05 carry-forward + 04 arising due to superannuation) vacancies are hereby re- determined for the Select List of 2024 for appointment by promotion of eligible officers of the Assam Police Service to the Assam segment of the Joint Assam-Meghalaya Cadre of the Indian Police Service.

4. The State Government and the Union Public Service Commission are requested to take further necessary action in the matter in accordance with the provisions of the IPS (Appointment by Promotion) Regulations, 1955.
