Sub: Determination of vacancies for appointment by promotion of officers from State Police Service to the Indian Police Service of Andhra Pradesh Cadre for the Select List year 2022 and 2023.

Sir,

I am directed to refer to Government of Andhra Pradesh letter No. 1942696/SC.C/A1/2022 dated 08.01.2024 on the subject cited and to say that the last Select List was prepared and finalized for the year 2020-2021 by Selection Committee in the meeting held on 23.01.2023 and 07 & 02 appointments were made against 08 and 02 vacancies for the Select List of the years 2020 and 2021 respectively vide this Ministry's Notification dated 09.03.2023. The name of Shri B Umamaheswar was included in the Select List 2020 provisionally subject to clearance in the criminal proceedings against him and grant of integrity certificate by the State Government. As such, he could not be appointed to IPS. In terms of Rule 7(4) of the IPS (Appointment by Promotion) Regulation, the validity of Select List 2020-2021 was upto 31.12.2023 and therefore 01 vacancy from Select List 2020, against which Shri B Umamaheswar was included provisionally; have to be carried forward to year 2022.

2. Further, State Government has informed that 05 vacancies have arisen for the Select List year 2022 due to retirement of 05 officers during the year 2022 and 01 vacancy which remained unfilled from the Select List year 2020, is to be carried forward to the SL 2022. Therefore, State Govt. has requested to determine total 06 (05+01) vacancies for the SL 2022. Further, State Govt. has requested to determine 02 vacancies for the SL 2023, which have arisen due to retirement of 02 officers during the year 2023.

3. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with Regulation 5(1) of IPS (Appointment by Promotion) Regulations, 1955, **06 vacancies** for the Select List **2022** and **02 vacancies** for the Select List **2023** are determined for appointment by promotion of Andhra Pradesh Police Service officers to the Indian Police Service of Andhra Pradesh Cadre.

4. The State Government and the Commission are requested to take further necessary action as required under the IPS Promotion Regulations.
