Subject: Re-determination of vacancies for appointment by promotion of officers from State Police Service to the Andhra Pradesh Cadre of Indian Police Service for the Select List - 2020 and determination of vacancies for Select List -2021.

Sir,

I am directed to refer to the Government of Andhra Pradesh letter No. 1319207/SC.C/A1/2021 dated 24.05.2022 on the subject cited and to say that this Ministry has determined 03 vacancies for the select list year 2020 vide letter No. 14011/23/2020-IPS I dated 12.04.2021. The last Select List was prepared and finalized for the year 2014-2019 vide Notification no. I-14011/27/2021-IPS-I (II) dated 30.12.2021, wherein 21 vacancies have been filed against 26 vacancies. 05 vacancies remained unfilled from Select List for the year 2014-2019, which are to be carried forward to Select List for the year 2020. Therefore, vacancies for the Select List 2020 is re-determined as 08 (03+05) in total.


2. Further, the authorised promotion quota of Andhra Pradesh Cadre of IPS as on 01.01.2022 is 43 and State Govt. has mentioned that total 33 officers are in position on the due date, which makes a total of 10 vacancies. Out of the 10 vacancies, 08 vacancies are being determined for year 2020. The remaining 02 vacancies are from year 2021 due to retirement of 02 promotee IPS Officers of Andhra Pradesh Cadre.

3. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with Regulation 5 (1) of the IPS (Appointment by Promotion) Regulations, 1955, **08 (03+05) vacancies** are re-determined for Select Lists of the year **2020** and **02 vacancies** are determined for Select Lists of the year **2021** for appointment by promotion of Andhra Pradesh SPS Officers to IPS of Andhra Pradesh Cadre.



4. The State Government and the Commission are requested to take further necessary action as required under the IPS (Appointment by Promotion) Regulations, 1955.
