**Subject: Determination of vacancies for appointment by promotion of officers from SPS to Indian Police Service of Chhattisgarh Cadre for the Select List 2022.**

Sir,

I am directed to refer to Government of Chhattisgarh letter No. F 1-12/2022/दो-गृह/भापुसे dated 14.02.2023 on the subject cited and to say that last Select List was prepared and finalized for the year 2019 where 02 vacancies were determined and 01 vacancy was kept in abeyance in compliance of interim order dated 04-09-2018 of Hon'ble CAT, Jabalpur Bench in O.A. No. 200/830/2018 filed by Shri Yash Pal Singh. Therefore, the Select List 2019 was prepared for 02 vacancies and the appointments were accordingly. This Ministry has already determined the vacancies of the Select list 2020 and 2021 as 04 and 02 respectively. The meeting of the Selection Committee for selection and appointment for the year 2020 and 2021 are yet to be held.

2. The authorized promotion quota of Chhattisgarh Cadre of IPS as on 01.01.2023 is 43 whereas 34 officers were in position on the due date, thus making 09 vacancies in total. Out of these 09 vacancies, 04 and 02 vacancies have already been determined for the Select List 2020 and 2021, 01 vacancy was kept in abeyance in compliance of interim order dated 04-09-2018 of Hon'ble CAT, Jabalpur Bench in O.A. No. 200/830/2018 filed by Shri Yash Pal Singh and 02 vacancies have been arisen due to retirement of 02 officers during the year 2022.

3. On the basis of above, in terms of the provisions contained in Rule 4 (2) (3) of the IPS Recruitment Rules, 1954 read with IPS (Appointment by Promotion) Regulations, 1955, **02 (Two)** vacancies are determined for the Select List 2022 for appointment by promotion of Chhattisgarh State Police Service to Chhattisgarh Cadre of Indian Police Service.

4. The State Government and the Commission are requested to take further necessary action as required under the IPS Appointment by Promotion Regulations, 1955.
