**Subject: Re-determination of vacancies for the Select Lists 2020, 2021 and 2022 for appointment by promotion of officers from SPS to Indian Police Service of Chhattisgarh.**

Sir,

I am directed to refer to Government of Chhattisgarh letter No. पुमु/समनि/दुसं/राय/निस/808/2023 dated 25.05.2023 on the subject cited and to say that last Select List was prepared and finalized for the year 2019 where 02 vacancies were determined and 01 vacancy was kept in abeyance in compliance of interim order dated 04.09.2018 of Hon'ble CAT, Jabalpur Bench in O.A. No. 200/830/2018 filed by Shri Yash Pal Singh. Therefore, the Select List 2019 was prepared for 02 vacancies and the appointments were accordingly.

2. This Ministry vide letters No. 14011/21/2021 IPS I(E) dated 25.03.2022, 14011/21/2021 IPS I(E) dated 08.04.2022, 14011/18/2023 IPS I (E) dated 22.02.2023 has already determined the vacancies of the Select list 2020, 2021 and 2022 as 04, 02 and 02 respectively and 01 vacancy was kept in abeyance in compliance of interim order dated 04.09.2018 of Hon'ble CAT, Jabalpur Bench in O.A. No. 200/830/2018 filed by Shri Yash Pal Singh.

3. Hon'ble Tribunal vide its order dated 23.05.2023 has vacated the abeyance vacancy. Operative para of the order dated **23.05.2023** is as under:

*"Therefore, inteirm order passed by this Tribunal on 04.09.2018 is hereby modified wherein by way of ad-interim measure, keeping the selection of one post in abeyance till the regular interim relief is considered, is hereby vacated and it is directed that official respondent authority will proceed further to carry out the DPC to be conducted on 01.06.2023 as per rules and regulations and seniority and year the final outcome of applicant shall be subject to this Original Application.*

*List this matter for hearing on 03.11.2023".*

4. Since, the Select list 2020, 2021 and 2022 has not been finalized and Hon'ble Tribunal vide its order dated 23.05.2023 has vacated the abeyance vacancy, therefore, in terms of IPS (Appointment by Promotion) Regulations, 1955, the de-reserved vacancy of the 2017 Select List may be added to the vacancies determined for the first unprepared Select List, i.e. of 2020.

5. On the basis of above, in terms of the provisions contained in Rule 4 (2) (3) of the IPS Recruitment Rules, 1954 read with IPS (Appointment by Promotion) Regulations, 1955, **05 (Five) vacancies (04 vacancies + 01 de-reserved vacancy)** are determined for the Select List 2020 for appointment by promotion of Chhattisgarh State Police Service to Chhattisgarh Cadre of Indian Police Service.

6. The vacancies determined for the Select List 2021 and Select List 2022 vide this Ministry's letters No 14011/21/2021 IPS I (E) dated 08.04.2022, 14011/18/2023 IPS I (E) dated 22.02.2023 will be unchanged.

7. The State Government and the Commission are requested to take further necessary action as required under the IPS Appointment by Promotion Regulations, 1955.
