Subject:- Determination of vacancies for appointment by promotion of State Police Officers of Jharkhand to Indian Police Service of Jharkhand Cadre from the Select List of the year 2020.

Sir,

I am directed to refer to State Govt.'s letter no. 13/P-2-101/2021/2057 dated 07.06.2021 on the subject cited above and to say that the authorized promotion quota in **Jharkhand Cadre** of IPS as on 01.01.2021 was 45, whereas 21 officers were in position on the due date. Out of the 24 vacancies (45-21), vacancies for year 2017 (09), 2018 (04) & 2019 (05) have already been determined but the Select Lists for 2017, 2018 & 2019 are yet to be finalized. **State Govt. is requested to finalize the pending Select Lists of year 2017, 2018 & 2019 at the earliest.**

2. The remaining 06 vacancies [45 – (21 + 9 + 4 + 5)] have arisen due to retirement of 06 officers during the year 2020 for preparation of Select List 2020.

3. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with IPS (Appointment by Promotion) Regulations, 1955, 06 vacancies are determined for the Select List of the year 2020 for appointment by promotion of State Police Officers of Jharkhand to Indian Police Service of Jharkhand Cadre.

4. State Govt. and the Commission are requested to take further necessary action as required under the IPS Appointment by Promotion Regulations 1955.
