**Subject: Re-determination of vacancies for Kerala Cadre of Indian Police Service for the Select List - 2021 - reg.**

Sir,

I am directed to refer to this Ministry's letter No. I-14011/05/2021-IPS I dated 23.05.2022, No. I-14011/14/2023-IPS I dated 26.04.2023, I-14011/14/2023-IPS I dated 29.11.2023, Government of Kerala's letter No. AIS-C3/363/2022/GAD dated 27.01.2023, No. AIS-C3/369/2022/GAD dated 11.04.2023, No. AIS-C3/1/2022/GAD dated 10.11.2023 & No. AIS-C3/01/2022/GAD dated 11.03.2024 on the subject cited and to say that this Ministry had determined 14 vacancies for the Select List 2021 vide letter dated 29.11.2023.

2. The Review Select List for the year 2020 notified vide letter dated 19.01.2024, Shri Kishore Kumar J was included provisionally subject to clearance in disciplinary proceedings pending against him and grant of Integrity Certificate by the State Government. As per Regulation 7(4) of the Indian Police Service (Appointment by Promotion) Regulations, 1955, the validity of the review Select List 2020 was up to 09.03.2024. However, State Govt. has not granted Integrity Certificate in respect of Shri Kishore Kumar J, who was included provisionally in the Select List 2020 subject to clearance in disciplinary proceedings pending against him and grant of Integrity Certificate by the State Government, therefore the vacancy remains unfilled in 2020 due to non-appointment of Shri Kishore Kumar J is required to be carried forward to the year 2021, taking the number of vacancies for that year to 15 (fifteen).

3. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with Regulation 5(1) of IPS (Appointment by Promotion) Regulations, 1955, **15 (01 carry forward + 14 Superannuation)** vacancies are re-determined for the Select List of the year 2021 for appointment by promotion of Kerala Police Service officers to the Kerala Cadre of Indian Police Service.

4. The State Government and the Commission are requested to take further necessary action as required under the IPS Promotion Regulations.
