Subject: Re-determination of vacancies for Kerala Cadre of Indian Police Service for the Select List - 2021 and determination of vacancies for the Select List - 2022- reg.

Sir,

I am directed to refer to this Ministry's letter No. I-14011/05/2021-IPS I dated 23.05.2022 and Government of Kerala's letter No. AIS-C3/363/2022/GAD dated 27.01.2023 & letter No. AIS-C3/369/2022/GAD dated 11.04.2023 on the subject cited and to say that the last Select List was notified for the year 2019 and 2020 vide which **08** and **13** appointments were done vide notification dated 16.11.2022 for the Select list years 2019 and 2020 against **09** vacancies for year 2019 & **14** for year 2020 respectively. **01** vacancy for Select List 2019 has been set aside as per orders of the Hon'ble CAT filed by Shri C. Bastin Sabu. Further, **01** name of Shri J Kishore Kumar was included in Select List 2020 provisionally subject to clearance in disciplinary proceedings pending against him and grants of Integrity Certificate by the State Government. Since, the Select List was valid upto 31.12.2022, this one vacancy needs to be carried forward to year 2021. As such, already determined vacancies (14) for Select List 2021

2. As per State Govt., as on 01.01.2023, **31** promotee IPS Officers were in position against the promotion quota of **52**, which makes a total of **21 vacancies**. Out of these 21 vacancies, 14 vacancies have already been determined for year 2021, while **05** vacancies have arisen due to superannuation of 05 promotee IPS Officers during the year 2022. Further, **01** unfilled vacancy for Select List 2019 has been set aside as per orders of the Hon'ble CAT filed by Shri C. Bastin Sabu, while **01** vacancy from Select List 2020, occupied due to inclusion of Shri J Kishore Kumar in Select List 2020 provisionally subject to clearance in disciplinary proceedings, needs to be carried forward to year 2021.

3. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with Regulation 5(1) of IPS (Appointment by Promotion) Regulations, 1955, **15 vacancies** (01 carry forward + 14 Superannuation) are re-determined for the **Select List of the year 2021** and **05 vacancies** are determined for the **Select List of the year 2022** for appointment by promotion of Kerala Police Service officers to the Kerala Cadre of Indian Police Service.

4. The State Government and the Commission are requested to take further necessary action as required under the IPS Promotion Regulations.
