Subject:- Re-determination of vacancies for appointment by promotion of officers from Kerala State Police Service to Kerala Cadre of Indian Police Service for the Select List - 2019.

Sir,

I am directed to refer to the subject cited above and to say that this Ministry vide letter of even number dated 21.01.2021 had determined **08** vacancies of the year 2019.

2. Further, meeting of the Selection Committee for promotion of SPS to IPS from the Select List 2018 was held on 24.06.2021 and MHA notified the Select List 2018 consisting of 11 officers vide Notification dated 30.09.2021. MHA has also notified the appointment order dated 30.09.2021 consisting of 09 officers excluding the names of Ramachandran T and Shri Jayakumar K (Jr). Shri Ramachandran T was not appointed to IPS as he was not in service and Shri Jayakumar K (Jr) was included in the Select List 2018 provisionally subject to clearance in the disciplinary proceedings pending against him. These 02 vacancies left unfilled in the Select List 2018 were carried forwarded to 2019 in terms of Department of Personnel & Training letter dated 15.09.2017. Accordingly, this Ministry vide letter of even number dated 05.01.2022 had determined **10** vacancies of the year 2019.

3. Subsequently, on the direction dated 18.03.2022 of the Hon'ble CAT, Ernakulam Bench in OA No. 180/520/2021, Shri Ramachandran T has been appointed against the Select List 2018 of Kerala Cadre vide letter dated 04.05.2022. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with Regulation 5(1) of IPS (Appointment by Promotion) Regulations, 1955, **09 (08 + 01) vacancies** are determined for the **Select List of the year 2019** for appointment by promotion of Kerala Police Service officers to the Kerala Cadre of Indian Police Service.
