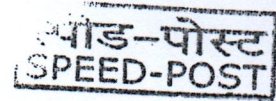

Subject: Determination of vacancies for appointment by promotion of Madhya Pradesh Cadre of Indian Police Service from the Select List of the year 2020.


Sir,
