Subject: Re-determination of vacancies for the Select List year 2020 & 2021 and determination of vacancies for the years 2022 & 2023 for appointment by promotion of officers from State Police Service to the Manipur Cadre of Indian Police Service.

Sir,

In supersession of this Ministry's letters No. 14011/11/2020-IPS I dated 18.02.2021, No. 14011/13/2022-IPS I dated 15.02.2022, I am directed to refer to State Government letter No. APPT-2/1/2023-DP-DP dated 12.02.2024 on the subject cited and to say that the last Select List was prepared and finalized for the Select List year 2016 to 2019 whereby 05 appointments were made out of 11 vacancies vide this Ministry's Notification dated 19.01.2023. Further, out of 05 officers who were appointed, Shri K. Ajit Kumar Sharma could not join IPS since he had already retired on 31.12.2022. As such, there were only 04 officers appointed against Select List 2016-2019.

- 2. With regard to Select List 2020, State Govt. has intimated that the authorised promotion quota of Manipur cadre as on 01.01.2021 was **27**, out of which **16** were in position, **04** officers appointed against Select List 2016-2019. MHA vide letter dated 18.02.2021 had determined **Nil** vacancy for the Select List 2020. Therefore out of 11 vacancies, **07** unfilled vacancies are to be carried forward to the Select List year 2020.
- 3. With regard to Select List 2021, State Govt. has intimated that out of **27** authorised promotion quota, **19** were in position, **07** vacancies for the Select List year 2020 have been proposed at para 2 above, 01 vacancy has been arisen in promotion quota of Manipur cadre for the Select List 2021 due to reversion of Shri Th. Brojen Singh to SPS on 14.07.2021. Accordingly, MHA already determined 01 vacancy for the Select List of 2021 vide letter dated 15.02.2022.
- 4. With regard to Select List 2022, State Govt. has intimated that out of **27** authorised promotion quota, **16** were in position, **07** vacancies have been proposed for the Select List year 2020 at para 2 above, **01** vacancy for the Select List of 2021 vide letter dated 15.02.2022 has been

determined and **03** vacancies have been arisen for the Select List year 2022 due to retirement.

- 5. With regard to Select List 2023, State Govt. has intimated that out of **27** authorised promotion quota, **12** were in position, **07** vacancies for the Select List year 2020 have been proposed at para 2 above, **01** vacancy for the Select List of 2021 vide letter dated 15.02.2022 has been determined, **03** vacancies have been proposed for the Select List year 2022 due to retirement at para 4 above and **04** vacancies have been arisen for the Select List year 2023 due to retirement.
- 6. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with IPS (Appointment by Promotion) Regulations, 1955, **07**, **01**, **03** and **04** vacancies are determined for the Select Lists of the years 2020, 2021, 2022 and 2023 respectively for appointment by promotion of Manipur Cadre of Indian Police Service.
- 7. Govt. of Manipur and the Commission are requested to take further necessary action as required under the IPS Appointment by Promotion Regulations 1955.
