Subject: Determination of vacancies for appointment by promotion of Manipur Cadre of Indian Police Service from the Select List of the year 2021.

Sir,

I am directed to refer to State Government letter no. APPT-2/1/2021-DP-DP-Part (2) dated 10.02.2022 on the subject cited and to say that the authorized promotion quota of Manipur Cadre of IPS as on 01.01.2022 is 27, whereas 15 Officers are in position and 11 vacancies has already been determined for the Select Year 2016 to 2019.

2. The last meeting of the Selection Committee to fill the 11 vacancies for year 2016 to 2019 was held on 03.12.2021. This Ministry vide letter dated 12.01.2022 has given its recommendation to the Commission on the minutes without any modification. UPSC vide letter dated 27.01.2022 suggested Govt. of Manipur to take necessary action for vacation of the Order of the Hon'ble High Court of Manipur regarding maintenance of status-quo, so that further action for finalization of the recommendations of the SCM held on 03.12.2021 can be taken.

3. Further, during the year 2021, 01 vacancy has been arisen in promotion quota of Manipur cadre for the Select List 2021 due to reversion of Shri Th. Brojen Singh to SPS on 14.07.2021.

4. Thus, 01 vacancy is available in the promotion quota of Manipur Cadre of IPS for preparation of the Select List of 2021 due to reversion of Shri Th. Brojen Singh to SPS.

5. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with IPS (Appointment by Promotion)

Regulations, 1955, **01** vacancy is determined for the Select List of the year 2021 for appointment by promotion of Manipur Cadre of Indian Police Service.

6. Govt. of Manipur and the Commission are requested to take further necessary action as required under the IPS Appointment by Promotion Regulations 1955.
