
I am directed to refer to Government of Punjab letter No. 1/32/2017-4H1/2516 dated 07-11-2019 on the subject and to say that the authorized quota of Punjab Cadre of IPS as on 01.01.2019 is 172, out of which 120 are the direct recruitment posts and 52 promotion posts. 02 vacancies for year 2014 have already been determined vide letter I- 14011/22/2015-IPS-I dated 07-04-2015. The vacancy determination for year 2015 to 2018 is as under:-

2. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with Regulation 5(1) of IPS (Appointment by Promotion) Regulations, 1955, 02 vacancies are determined for the Select List of the year 2015, 07 for Select List 2016, 05 for Select List 2017 and 03 for Select List 2018 for appointment by promotion of Punjab Police Service officers to the Punjab Cadre of Indian Police Service.

3. The State Government and the Commission are requested to take further necessary action as required under the IPS Promotion Regulations.
