**Sub: Re-determination of vacancies for appointment by promotion of officers from State Police Service to the Punjab Cadre of Indian Police Service for the Select List - 2019 & 2020 and determination of vacancies for Select List - 2021.**

Sir,

I am directed to refer to the State Government of Punjab's letter number 1/04/2021-4H1/2082 dated 30.09.2022 on the subject cited above and to say that this Ministry vide letter No. 14011/22/2020-IPS-1 dated 07.08.2020 had determined 05 vacancies for the Select List 2019. Further, 01 vacancy was determined for the Select List of 2020 vide letter No. 14011/17/2021-IPS-1 dated 24.03.2021.

2. The last Select List was prepared and finalized for the years 2010-2018 where **28** appointments were made against **38** vacancies. Thus, 10 unfilled vacancies in the Select List 2010-2018, may be in terms of Department of Personnel & Training letter dated 15.09.2017, carried forwarded for the Select List of year 2019.

3. Besides, Ms. Amrit Brar (Retired on 31.10.2019) and Shri Sukhminder Singh Mann appointed to IPS on 05.11.2013 and 10.03.2015 against Select Lists 2012 and 2013 respectively were not included in revised Select Lists. Further, Out of these 28 officers, appointed vide their notifications dated 07.04.2021, 23.12.2021 and 30.12.2021, 13 new officers were appointed. There were 33 officers including Ms. Amrit Brar (Retired on 31.10.2019) and Shri Sukhminder Singh Mann were in position as on 01.01.2019. As such, after excluding these 02 officers, there remain 44 (33-02+13) officers remain in position as on 01.01.2019. The vacancy of Ms. Amrit Brar was also included in the 05 vacancies determined for the year 2019. Therefore, 04 vacancies become available due to retirement during the year 2019.

4. The authorised promotion quota of Punjab Cadre of IPS as on 01.01.2020 is 52, where 40 officers are in position on the due date which makes a total of 12 vacancies for the Select List of 2019 due to retirement.

5. Further, the authorised promotion quota of Punjab Cadre of IPS as on 01.01.2021 is 52, where 39 officers are in position on the due date which makes a total of 13 vacancies. Out of the 13 vacancies, 12 vacancies have been re-determined for Select List:2019. Hence, **01** vacancy is determined for the Select List of 2020, which is due to retirement.

6. Also, the authorised promotion quota of Punjab Cadre of IPS as on 01.01.2022 is 52, where 34 officers are in position on the due date which makes a total of 18 vacancies. Out of the 18 vacancies, 12 vacancies have been re-determined for Select List:2019 and 01 vacancy has been re-determined for Select List:2020. Hence, **05** vacancies is determined for the Select List of 2021, which is due to retirement.

7. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with Regulation 5 (1) of IPS (Appointment by Promotion) Regulations, 1955 the vacancy Determination / Re-determination for the year 2019 to 2021 in respect of Punjab Cadre is determined as under:
