Saisekhar), can be carried forward to Select List 2022.

3. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with Regulation 5(1) of IPS (Appointment by Promotion) Regulations, 1955, **02** vacancies are re-determined for the Select List of the year **2022** for appointment by promotion of Telangana Police Service officers to the Indian Police Service of Telangana Cadre.

4. The State Government and the Commission are requested to take further necessary action as required under the IPS Promotion Regulations.
