**Sub:- Determination of vacancies for appointment by promotion of officers from State Police Service to the Tripura Cadre of Indian Police Service for the Select List 2022 - reg.**

Sir,

I am directed to refer to Government of Tripura letter number F.2(11)-GA(P&T)/2022 dated 23.12.2022 on the subject cited above and to say that the authorized promotion quota of Tripura Cadre of IPS as on 01.01.2023 was 21, whereas 10 officers are in position on due date, which makes a total of 11 vacancies. Out of these 11 vacancies, MHA vide letter number I-14011/09/2018-IPS.I(E) dated 21.02.2018 has determined 03 vacancies for the year 2017, vide letter number 14011/09/2019-IPS.I(E) dated 11.08.2021 has determined 01 vacancy for the year 2018, 01 vacancy for the year 2019 and 03 vacancies for the year 2020 and vide letter dated 31.01.2022 has determined 01 vacancy for the year 2021. However, the aforesaid 09 vacancies have not been filled up till date due to pendency of SLP before Hon'ble Supreme Court of India in connection with reservation policy of the State Govt.

2. As regards, Select List 2022, State Govt. has intimated that 02 vacancies have arisen against promotion quota due to retirement of two officers namely (i) Shri Arindam Nath, IPS (TR:2003) on 31.10.2022 and (ii) Shri Kamal Chakraborty, IPS (TR:2011) on 31.05.2022.

3. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with IPS (Appointment by Promotion) Regulations, 1955, 02 vacancies are determined for the Select List of the year 2022 for appointment by promotion of officers from Tripura State Police Service to Tripura Cadre of Indian Police Service.

4. The State Government and the Commission are requested to take further necessary action as required under the IPS (Appointment by Promotion) Regulations, 1955.
