Sir,

I am directed to refer to State Govt. 's letter no. F.2(5)-GA(P&T)/21 dated 30.07.2021 on the subject cited above and to say that the authorized promotion quota of Tripura Cadre of IPS as on 01.01.2021 was 21, whereas 13 officers are in position on due date, which makes a total of 08 vacancies. Out of these 08 vacancies, 03 vacancies have already been determined for year 2017 vide letter I-14011/09/2018-IPS.I (E) dated 21.02.2018. The remaining 05 vacancies have occurred due to retirement/superannuation of officers during year 2018 (01), 2019 (01) & 2020 (03).

2. Therefore, in terms of the provisions contained in Rule 4 (2) (3) of the IPS Recruitment Rules, 1954 read with IPS (Appointment by Promotion) Regulations, 1955, 01 vacancy is determined for the Select List of the year 2018, 01 vacancy for 2019 & 03 vacancies for year 2020 for appointment by promotion of Tripura State Police Service to Tripura Cadre of Indian Police Service.

3. The State Government and the Commission are requested to take further necessary action as required under the IPS Appointment by Promotion Regulations 1955.
