Sub: Re-determination of vacancies for appointment by promotion of officers from State Police Service to the West Bengal Cadre of Indian Police Service for the Select List - 2019 and determination of vacancies for Select List - 2022.

Sir,

I am directed to refer to the State Government of West Bengal's letter number 310-P.S Cell/HR/O/3P-01/2022 dated 03.03.2023 on the subject cited above and to say that that the last Select List was prepared and finalized for the year 2018 where 10 appointments were made against 11 vacancies. The remaining 01 vacancy could not be filled w.r.t. Shri Jayanta Mukherjee due to pending disciplinary proceedings & Integrity Certificate in this regard. The validity of Select List 2018 was till 28.02.2023 and now this 01 vacancy need to be forwarded to year 2019.

2. This Ministry has already determined vacancies for the years 2019, 2020 and 2021 as 02, 05 and 02 respectively vide letter No: 14011/16/2022-IPS I dated 12.04.2022. Since, 01 vacancy of the Select List 2018 could not be filled and the validity of Select List 2018 was till 28.02.2023, this unfilled vacancy is carried forward to Select List:2019 and the vacancies for the Select List 2019 is re-determined as **03** (02+01).

3. Further, the authorised promotion quota of West Bengal Cadre of IPS as on 01.01.2023 is 105, where 79 officers are in position on the due date which makes a total of 26 vacancies. Out of the 26 vacancies,

- (i) 10 vacancies has already been filled for the Select List 2018
- (ii) 03 vacancies are to be re-determined for Select List 2019.
- (iii) 05 and 02 vacancies have already been determined for the Select Lists of the years 2020 and 2021 respectively.
- (iv) Remaining 06 vacancies have been arisen due to retirement of 06 officers during the year 2022.

4. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with Regulation 5 (1) of IPS (Appointment by Promotion) Regulations, 1955 the vacancies are re-determined as **03** for the Select List **year 2019** and vacancies are determined as **06** for the Select List **year 2022**.

5. The State Government and the Commission are requested to take further necessary action as required under the IPS Appointment by Promotion Regulations 1955.
