Sub: Re-determination of vacancies for appointment by promotion of officers from State Police Service to the West Bengal Cadre of Indian Police Service for the Select List – 2018 & 2019 and determination of vacancies for Select List – 2020 and 2021.

Sir,

I am directed to refer to the State Government of West Bengal's letter number 238-PS Cell/HR/O/3P-01/2022 dated 28.02.2022 on the subject cited above and to say that this Ministry vide letter No. 14011/22/2019-IPS-1 dated 18.07.2019 had determined 08 vacancies for the Select List 2017 and 09 vacancies for the Select List 2018. Further, 02 vacancies were determined for the Select List of 2019 vide letter No.14011/25/2020-IPS-1 dated 16.12.2020.

- 2. The last Select List was prepared and finalized for the year 2017 where **06** appointments were made against 08 vacancies. 02 vacancies remained unfilled from Select List: 2017, which are to be carried forward to Select List:2018. Therefore, vacancies for the Select List 2018 is re-determined as **11** (09+02). Further, this Ministry has already determined the vacancies for the year 2019 as **02**.
- 3. The authorised promotion quota of West Bengal Cadre of IPS as on 01.01.2021 is 105, where 81 officers are in position on the due date which makes a total of 24 vacancies. Out of the 24 vacancies, **05** vacancies {24-(06+11+02)} are determined for the Select List of 2020 due to retirement.
- 4. Further, the authorised promotion quota of West Bengal Cadre of IPS as on 01.01.2022 is 105, where 85 officers are in position on the due date which makes a total of 20 vacancies. Out of the 20 vacancies, 11, 02, 05 vacancies have been determined / re-determined for Select List:2018, 2019 & 2020 respectively. Hence, **02** vacancies {20-(11+02+05)} are determined for the Select List of 2021, which are due to retirement.

5. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with Regulation 5 (1) of IPS (Appointment by Promotion) Regulations, 1955 the vacancy Determination / Re-determination for the year 2018 to 2021 in respect of West Bengal Cadre is determined as under:
