Sub;- Re-Determination of vacancies for appointment by promotion of West Bengal Cadre of Indian Police Service from the Select List of the year- 2017 and determination for the vacancies of the Select List of 2018.

Sir,

I am directed to refer to State Government letter No- 226-P.S.Cell/HR/O/3P-04/19 dated 13<sup>th</sup> February 2019 on the subject cited and to say that this Ministry had determined the vacancies for the Select List of 2016 (16 Vacancies) & 2017 (05 Vacancies) vide this Ministry's letter dated 22/01/2018 and 24/04/2018. Out of 16 Vacancies for the Select List-2016 only 13 eligible officers were appointed. 03 vacancies are left in the Select List of 2016 and these 03 vacancies are to be carry forward to the Select List of 2017. Now, in the Select List of 2017, 05 + 03=08 vacancies are available.

- 2. The authorized promotion quota of West Bengal Cadre of IPS as on 01/01/2019 is 105 and in position strength is 75. Therefore, as on 01/01/2019 there are 30 vacancies. Whereas 13 officers for Select List of 2016 appointed on 19/02/2019 and 08 vacancies (05+03 carry forward from Select List of 2016) for the Select list of 2017. 09 vacancies that is available in the Select List of 2018 is due to superannuation of promote officers during the year 2018.
- 3. In terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with Regulations 5 (1) of the IPS (Appointment by Promotion) Regulations, 1955, re-determine the vacancies for the Select List of 2017 from 05 to 08 and determine the vacancies for the Select List of 2018 as 09 in all for appointment by promotion of West Bengal Cadre of Indian Police Service.
- 4. The State Government and the Commission are requested to take further necessary action as required under the IPS (Appointment by Promotion) Regulations, 1955.
