**Sub: Determination of vacancies for appointment by promotion of officers from Karnataka State Police Service to Karnataka Cadre of Indian Police Service for the Select List 2021.**

Sir,

I am directed to refer to the State Government of Karnataka's letter number e-DPAR 11 SPS 2019 dated 06.01.2022 on the subject cited and to say that the authorized promotion quota of **Karnataka** Cadre of IPS as on 01.01.2020 was 65, whereas 33 officers are in position on the due date which makes a total of 32 vacancies to come into effect. Out of these 32 vacancies, **28** vacancies have already been determined for year 2016 (17), 2017 (03), 2018 (04) & 2019 (04). Out of 28 vacancies, appointment order against 26 vacancies have been issued vide Notification number 14011/03/2021-IPS1 dated 10.12.2021. Further, 04 vacancies were determined for the year 2020 vide this Ministry's letter number 14011/03/2021-IPS1 dated 13.01.2021. State Government has stated that there was no eligible officer for promotion for select list 2020.

2. In view of the above, total **06 (02+04)** unfilled vacancies have to be carried forward. Further, State Govt. has intimated that during the year 2021, Dr. K.V.Jagadish, IPS (KTK:2012), promote officer demised on 26.09.2021. Therefore, seven (07) consequential vacancies are available for the Select List 2021.

3. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with IPS (Appointment by Promotion) Regulations, 1955, **07 vacancies** are determined for the **Select List 2021** for appointment by promotion of Karnataka State Police Service to **Karnataka Cadre** of Indian Police Service.

4. The State Government and the Commission are requested to take further necessary action as required under the IPS Appointment by Promotion Regulations 1955.
