Sub: Re-determination of vacancies for Select List 2019 & determination of fresh vacancies for select List 2020 - reg.

Sir,

I am directed to refer to the State Government's letter number IPS0420/C. R.-19/POL-1 dated 12.01.2021 on the subject cited and to say that the authorized promotion quota of Maharashtra Cadre of IPS as on 01.01.2021 was 96, whereas 81 officers are in position on the due date which makes a total of 15 vacancies. Out of these 15 vacancies, 08 vacancies have already been determined for year 2019 and 01 vacancy has been carried forward from SI-2017 to SI-2019 due to non-appointment of Shri P. B. Sawant within the validity of Select Lists 2017 & 2018. This makes the total vacancies for year 2019 as **09**. The remaining 06 vacancies have arisen due to retirement of 06 IPS officers during the year 2020.

2. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with IPS (Appointment by Promotion) Regulations, 1955, **09 vacancies** are re-determined for **Select List 2019** and **06 vacancies** are determined for **Select List 2020** for appointment by promotion of Maharashtra State Police Service to Maharashtra Cadre of Indian Police Service.

3. The State Government and the Commission are requested to take further necessary action as required under the IPS Appointment by Promotion Regulations 1955.


