I am directed to refer to State Government letter No. HPL 6/2017/Pt.II/69 dated 06.01.2025 on the subject cited and to say that the last Selection Committee meeting for preparing Select List of year 2023 was held on 26.06.2024 and accordingly, 02 appointments were made against 03 vacancies for the Select List of the year 2023 vide Notification dated 02.08.2024. The name of Shri Gabriel Kitkupar Langrai, was included in the Select List 2023 provisionally subject to clearance in the disciplinary and criminal proceeding against him and grant of Integrity Certificate by the State Government.

- 2. The authorized promotion quota of Meghalaya Segment of Joint Assam-Meghalaya Cadre of IPS as on 01.01.2025 was 17, whereas 14 officers were in position on the due date, which make 03 vacancies in total. Out of 03 vacancies, 01 vacancy has arisen due to non-appointment of Shri Gabriel Kitkupar Langrai, who was included provisionally in the select list 2023 and 02 vacancies have arisen due to retirement of 02 officers during the year 2024.
- 3. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with Regulation 5(1) of IPS (Appointment by Promotion) Regulations, 1955, **03** vacancies are determined for the Select List of the year **2024** for appointment by promotion of Meghalaya Police Service officers to Indian Police Service of Meghalaya Segment of Joint Assam-Meghalaya Cadre.
- 4. The State Government and the Commission are requested to take further necessary action as required under the IPS Promotion Regulations.
