Sub:- Determination of vacancies for appointment by promotion of officers from Maharashtra State Police Service to Maharashtra Cadre of Indian Police Service for the Select List- 2017.


Sir,

I am directed to refer to the State Government's letter No.IPS 0718/C.R-66/POL-I dated 10th May, 2018 on the subject cited and to say that the authorized promotion quota of Maharashtra Cadre of IPS as on 01.01.2018 was 91, whereas 76 officers were in position on the due date. 09 vacancies for the Select List- 2016 for promotion quota of Maharashtra Cadre of IPS have already sent to UPSC. Out of 9 officers 2 officers are included provisionally subject to clearance of their criminal proceedings and departmental proceeding. As per Rule 7 (4) the select list shall remain in force till 31st December of the year in which the SCM was held under regulation (1) of regulation 5 or sixty days from the date of approval whichever is later. The Selection Committee Meeting for the Select List- 2016 was held on 28.03.2018 and the Commission approval was on 18.05.2018. Therefore, as per Rule, the select List- 2016 shall remain in force till 31.12.2018. As such, now 06 vacancies are available due to retirement of 06 IPS officer's i.e. Shri A. V. Patil, Shri P. S. Patankar, Shri C. G. Daithankar, Shri S. E. Shinde, Shri K. E. Jadhav, Shri A. V. Jadhav.

2. Therefore, in terms of the provisions contained in Rule 4 (2) of the IPS Recruitment Rules, 1954 read with IPS (Appointment by Promotion) Regulations, 1955, **6 vacancies** are determined for the **Select List of the year 2017** for appointment by promotion of Maharashtra State Police Service to Maharashtra Cadre of Indian Police Service.

3. The State Government and the Commission are requested to take further necessary action as required under the IPS Appointment by Promotion Regulations 1955.
