// **ORDER** //

12 DEC 2017

Whereas, Ministry of Personnel, Public Grievances and Pensions, DOP&T vide O.M. No. 14014/14/2014-AIS-I dated 21.08.2017 intimated that in the wake of Hon'ble High Court of Punjab and Haryana order dated 01.02.2010 in CWP No. 15798/2009 in the case of Praveen Kumar, an State Civil Service officer of Punjab cadre Vs Union of India as confirmed by Hon'ble Supreme Court, issued notification dated 18.04.2012 for making amendment in the respective seniority regulations for IAS/IPS/IFoS. These amendments were however made applicable to the Select Lists prepared as per the ratio laid down in the case of Praveen Kumar and accordingly, seniority/year of allotment of the officers included in the said Select Lists were determined as per the amended seniority regulations.

2. Whereas, consequent upon dismissal of SLP No. 4930-4931 of 2016 and Review Petition No. 001428-001429/2017 filed by the DoP&T in case of F R Jamadar and other connected court cases filed by this Ministry, it was decided to apply the amended seniority regulations prospectively i.e. w.e.f. 18.04.2012. Accordingly, Seniority/year of allotment of the IPS officers appointed during 01.02.2010 to 18.04.2012 from the Select Lists prepared as per ratio laid down in the Praveen Kumar case would need to be re-determined as per the pre-amended seniority Regulations.

3. Further, as per clarification of DOP&T vide O.M. No. 14014/14/2014-AIS-I dated 03.11.2017 the seniority/year of allotment of the officers who were appointed later on but included in the Select List notified between 01.02.2010 to 18.04.2012 has to be determined as per the pre-amended seniority regulations since there could not be different rules for the officers of the same Select List for ones appointed during the said period and others appointed later on after 18.04.2012.

4. And, therefore, the seniority/year of allotment of the officers appointed by promotion to IPS of UT Segment of Joint AGMUT Cadre from the Select Lists 2010 has been modified in terms of pre-amended seniority rules as follows in supersession of this Ministry's order No. 15011/7/2012-IPS-I(II) dated 16.10.2017.

(iii) **Shri Brij Kishore Singh, B Srikanth, V J Chandran, R A Sanjeev, Rajesh Kumar and Prem Nath** shall be placed enblock below **Shri Nabam Gungte, (SPS: 2004)** the senior most SPS IPS officer of 2004 batch of the Arunachal Pradesh Segment of Jt AGMUT Cadre and above **Shri John Laldina, IPS (SPS: 2004)**, the junior most SPS IPS officer of 2004 batch of Mizoram Segment of Jt. AGMUT Cadre of IPS.

(iv) **Shri, Rishi Pal, Parwaiz Ahmed, Dheeraj Kumar, Ishwar Singh, Amrendra Kumar Singh, Ajit Kumar Singla, Omvir Singh, Mahender Nath Tiwari and Shri Raj Kumar Singh** shall be placed enblock below **Shri Madhur Verma (RR: 2005)**, the junior most direct recruit IPS officer of 2005 batch of the Joint AGMUT Cadre and above **Lalbiakthanga Khiangte (SPS: 2005)**, the junior most SPS IPS officer of 2005 batch of the Mizoram Segment of Joint AGMUT of IPS.

6. The seniority of Shri Ravindra Kumar Pandey and Shri Rajveer Singh (both officers of Select List-2011) was fixed vide this Ministry's order No. 15011/1/2014-IPS-I (II) dated 09.01.2014 and restricted to 2006 in pursuance with first proviso to Rule 3 (3)(ii) of IPS (Regulation of Seniority) Rules as Shri Raj Kumar Singh, the junior most officer appointed by promotion from the Select List of 2010 to the UT Segment of Joint AGMU Cadre was assigned 2006 as his year of allotment. As per order of this Ministry's dated 16.10.2017, the Seniority of Shri Raj Kumar Singh has been re-fixed as 2005 in place of 2006. Therefore, restriction is deleted and the seniority of Shri Ravindra Kumar Pandey and Shri Rajveer Singh is re-fixed and the seniority/allotment year is allotted as 2005 in place of 2006.

7. As per Rule 4 of the IPS (Regulation of Seniority) Rules, 1988, the placement of above officers in the Select List will be as under as per Civil List- 2017, **Shri Ravinder Kumar Pandey & Shri Rajveer Singh** shall be placed enblock below **Shri Raj Kumar Singh (SPS: 2005)**, the junior most SPS IPS officer of 2005 batch to the UT Segment of Joint AGMUT Cadre of IPS and above **Shri Lalbiakthanga Khiangte, (SPS: 2005)**, the junior most SPS IPS officer of 2005 batch of the Mizoram Segment of Joint AGMUT of IPS.
