I am directed to refer to UT Division's OM No. 14016/01/2025.UTS-I dated 07.04.2025 and 29.05.2025 on the subject cited above and to say that the last SCM for the Select List 2015-2020 of SPS officers of the erstwhile Jammu and Kashmir cadre was held on 21.07.2023 and Select List and appointment orders were notified vide Notification dated 29.09.2023 whereby 27 appointments were made against 32 vacancies. As such, the 05 unfilled vacancies of the Select Lists 2015-2020 due to non-appointment into the IPS need to be carried forward to the year 2021 for which this Ministry has determined 'nil' vacancy.
