I am directed to refer to this Ministry's letter of even number dated 6.5.2008 on the subject cited above. It was mentioned therein that the ACR of IPS officers for the year 2007-08 is to be initiated in the new PAR format.

- 2. A number of representations have been received from various State Governments regarding exemption from initiating the ACR for 2007-08 in the new PAR format since the intimation of revised PAR format was received by them during May 2008. It was also brought to the notice of this Ministry that in some cases, the Reporting/Reviewing/Accepting Authorities have already superannuated and as such, the reports in the new format could not be re-written within the stipulated period.
- 3. The matter was considered by this Ministry in consultation with Department of Personnel and Training. It has been decided by the Competent Authority, in relaxation of the Rules, that the assessment of the performance of Indian Police Service Officers for the year 2007-08, if it was written in the old ACR format, may be accepted.
